To assist facilities in adopting the guidelines provided by Accreditation Canada for effective skin and wound care management, the following indicators were added to the NISS Wound Record. Page 1 and 2 – For each wound site, lines have been added to calculate the surface area of the wound, to calculate the percentage change observed in the surface area of the wound, and to document any photos taken of wound.
